7.0 INFORMATION SESSION

7.1. Organization Update by Jason Watts, Chief Operating Officer.

Jason Watts updated the Board on the reopen status of all three campuses. All reopened in Distance Learning mode after the winter break. The Oceanside campus is expected to go to Hybrid Learning mode (with am and pm sessions) first, followed by the Santa Ana campus. South Bay still remains in Distance Learning mode as community spread is still rendering LA County in the purple tier. Mr. Watts disclosed that Scholarship Prep completed its first single audit which is required for non-federal entities that expend \$750k or more of federal grant money during the fiscal year. Mr. Watts mentioned that the transition to Charter Impact for back office services was going smoothly. Mr. Watts

also reported that the Home Office team led by Andrew Crowe is consistently meeting with the site administrators to share ideas and provide support.

Andrew Crowe updated the Board that the Santa Ana campus, a county-wide benefit charter school for Foster & Homeless Youth, identified a source of Title 1 funding to develop an on-site pantry. The Santa Ana Wellness Center & Pantry will be stocked with food to serve Scholarship Prep's McKinney Vento homeless and foster students.

7.1.1. Organization Fiscal Update by Darlington Ahaiwe, the Director of Client Finance for Charter Impact, and Spencer Styles, President & CEO.

Spencer Styles presented to the Board the monthly financial Report for January 2021. Scholarship Prep is doing well financially with a 10% surplus projected and expenses to be within 1% of their target. The surplus will help with potential cash flow issues in the 2021-22 school year due to the State's scheduled deferrals of funding.

7.2. Oceanside Campus Update by Valerie Douglass, Principal.

Valerie Douglass updated the Board on Oceanside campus' phased in on-site learning. 70 invitations were sent out to students to come to campus for special support services. All accepted the invitation to return for small group cohorts for academic support. The staff is diligently working on a plan to return to hybrid learning mode (am and pm sessions) in mid-March with approximately 300 scholars. Ms. Douglass mentioned that Daily Scholar socio-emotional check-ins are taking place for all 1st - 8th graders. Ms. Douglass announced that the Open Enrollment period for the next school year ended. 140 applications were submitted to go to the lottery for 19 available spots.

7.3. Santa Ana Campus Update by Dennise Allotey, Principal.

Dennise Allotey informed the Board that Open Enrollment for next school year was concluded and that the Lottery is scheduled for February 23rd. All 5th-8th grade Lady Scholars were invited to a virtual "National Introduce a Girl to Engineering Day." Ms. Allotey disclosed that the Santa Ana campus is preparing for a return to hybrid learning mode on March 22nd.

7.4. South Bay Campus Update by Harris Luu, Principal.

Harris Luu updated the board on the South Bay Campus. The school is patiently awaiting and preparing for the authorizer to reopen LAUSD schools. In the meantime, open

enrollment for the next school year is taking place, and the school has enrolled a few students since the last board meeting for this current school year. There is not much space available--mainly in the lower grades. Instructionally, South Bay is moving forward with internal benchmark assessment of all students, as well as ELPAC testing is taking place in March for EL learners. First Semester Awards were held remotely. Mr. Luu announced that they are working with the CA Charter Schools Association to create a video on South Bay's 2019-20 Teacher of the Year, Ms. Diane Ashbaugh.

7.5. Form 700 Training for Board Members by Michelle Anderson, Chief of Staff.

Michelle Anderson presented to the Board the 2020 Annual Form 700 and instructions for completing the form. Deadline for returning the Form to Scholarship Prep is March 1st.
